### **Milestones Supplemental Guide**

This document provides additional guidance and examples for the Pulmonary Critical Care Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

Additional tools and references, including the Milestones Guidebook, Clinical Competency Committee Guidebook, and Milestones Guidebook for Residents and Fellows, are available on the <u>Resources</u> page of the Milestones section of the ACGME website.

Milestone Levels:

Milestones are arranged into levels. Tracking from Level 1 to Level 5 is synonymous with moving from novice to expert in the subspecialty. For each reporting period, the Clinical Competency Committee will review the completed evaluations to select the milestone levels that best describe each learner's current performance, abilities, and attributes for each subcompetency.

These levels *do not* correspond with post-graduate year of education. Depending on previous experience, a junior fellow may achieve higher levels early in his/her educational program just as a senior fellow may be at a lower level later in his/her educational program. There is no predetermined timing for a fellow to attain any particular level. Fellows may also regress in achievement of their milestones. This may happen for many reasons, such as over scoring in a previous review, a disjointed experience in a particular procedure, or a significant act by the fellow.

Supervision requirements:

Direct Supervision: the supervising physician is physically present with the fellow and patient.

**Indirect Supervision with Direct Supervision Immediately Available:** the supervising physician is physically within the hospital or other site of patient care, and is immediately available to provide Direct Supervision.

Indirect Supervision with Direct Supervision Available: the supervising physician is not physically present within the hospital or other site of patient care but is immediately available to provide Direct Supervision by means of telephonic and/or electronic modalities.

Glossary of Terms

**Oversight:** the supervising physician is available to provide review of procedures/encounters with feedback provided after care is delivered.

**Substantial Guidance:** the supervising physician must provide extensive corrective suggestions, elaboration, or, for procedures, step in to assist or demonstrates some or all of the steps.

**Independently:** the supervising physician may have a few additional suggestions, but the interaction is more like a peer-to-peer discussion about a patient.

Levels between "substantial guidance" and "independently" assume graduated levels of independence and sophistication of the learner, with guidance and supervision appropriate to the skill of the learner.

Milestones	Examples
<b>Level 1</b> Manages unstable patients requiring a higher intensity of care, with substantial guidance	<ul> <li>Requires attending assistance in recognizing hypotension in a septic patient who needs a higher level of care</li> </ul>
Identifies the long-term consequences of critical illness, with substantial guidance	• Requires attending physician prompting to identify myopathy as a consequence of sepsis
Provides critical care consultation, with substantial guidance	• Requires attending physician guidance in the consultation of a patient with impending respiratory failure
<b>Level 2</b> Manages unstable patients with single system disease	<ul> <li>Recognizes hypotension and begins fluid resuscitation in a septic patient who needs a higher level of care</li> </ul>

Patient Care 3: Disease Management in Pulmonary Medicine Overall Intent: To provide comprehensive care for ambulatory and hospitalized patients with pulmonary disorders as either primary provider or consultant

<b>Level 1</b> Manages common pulmonary disorders in hospitalized patients, with substantial guidance	<ul> <li>Needs attending staff advice to undertake management of a cystic fibrosis patient during an exacerbation</li> </ul>
Manages common pulmonary disorders in ambulatory patients	<ul> <li>Requires attending staff advice to distinguish asthma from chronic obstructive pulmonary disease (COPD) and recommend appropriate therapy</li> </ul>
Provides pulmonary consultation for patients with common pulmonary disorders, with substantial guidance	• Requires attending staff assistance to provide differential diagnosis and recommendations for a consult regarding a patient with hospital acquired pneumonia
<b>Level 2</b> Manages common pulmonary disorders in hospitalized patients	<ul> <li>Manages an uncomplicated cystic fibrosis patient during an exacerbation</li> </ul>
Manages common pulmonary disorders in ambulatory patients and mitigates their disease risk factors	<ul> <li>Distinguishes asthma from COPD and recommend appropriate therapy including counseling on smoking cessation, necessary vaccinations, and avoidance of environmental exposures</li> </ul>

Patient Care 4: Pre-Procedure Assessment Overall Intent: To counsel patients regarding indications, risks, benefits, and alternatives of common procedures	
Milestones	Examples
<b>Level 1</b> Identifies indications for procedures and their risks, benefits, and alternatives	<ul> <li>Identifies that a patient has a new pleural effusion that may benefit from thoracentesis</li> </ul>
<b>Level 2</b> Assesses indications, risks, benefits and weighs alternatives in low- to moderate-risk situations	<ul> <li>Weighs the risks and benefits of a thoracentesis for a new pleural effusion in a patient without comorbidities</li> </ul>
<b>Level 3</b> Assesses indications, risks, benefits and weighs alternatives in high-risk situations	<ul> <li>Weighs the risks and benefits of a thoracentesis for a new pleural effusion in a patient with severe bullous emphysema</li> </ul>
<b>Level 4</b> Independently assesses indications, risks, benefits and weighs alternatives in high- risk situations and acts to mitigate modifiable risk factors	<ul> <li>Weighs the risks and benefits of a thoracentesis for a new pleural effusion in a patient with coagulopathy and proactively decides when to hold the anticoagulation and use real- time ultrasound</li> </ul>
